Standard Circular Connectors(4)

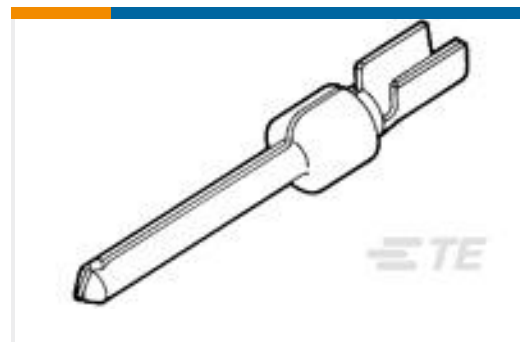
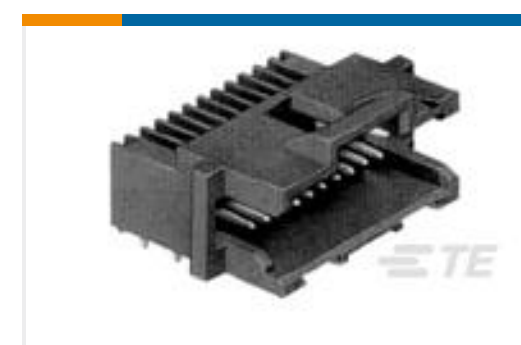


Standard Rectangular Connectors(10)
