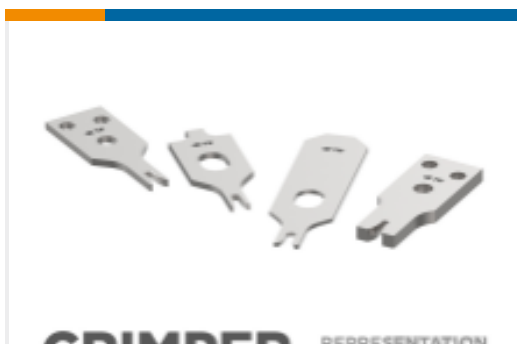
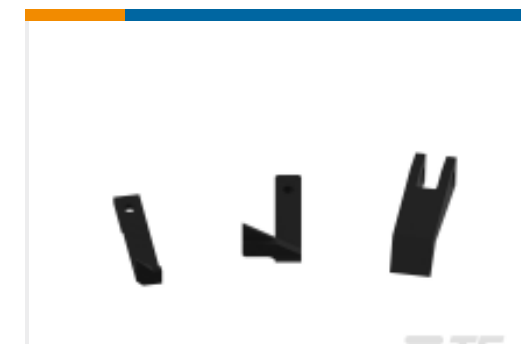
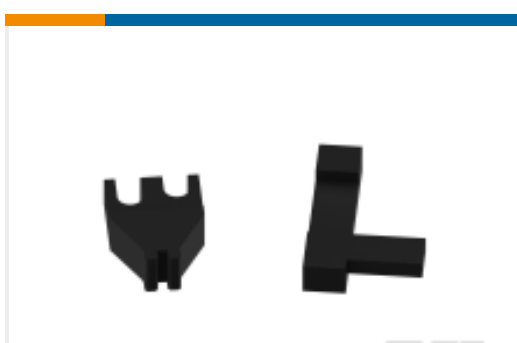


Standard Rectangular Connectors(10)
