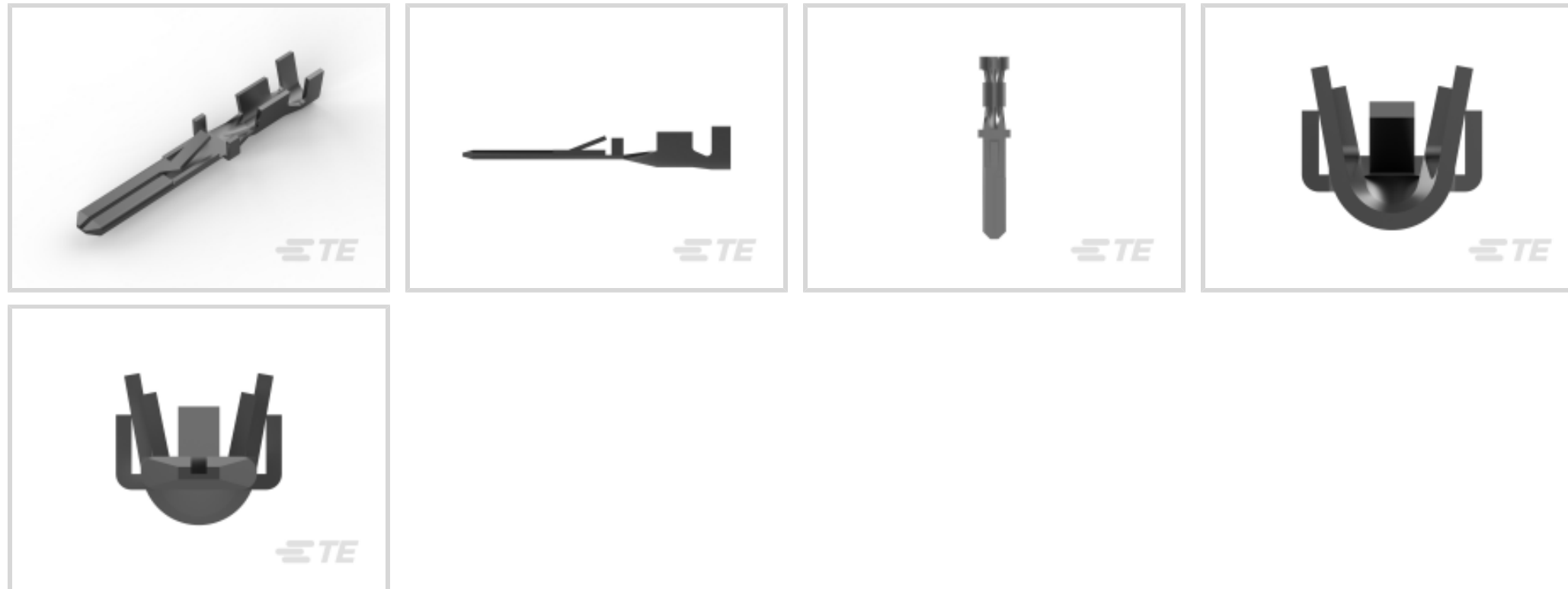





Automotive Housings(1)





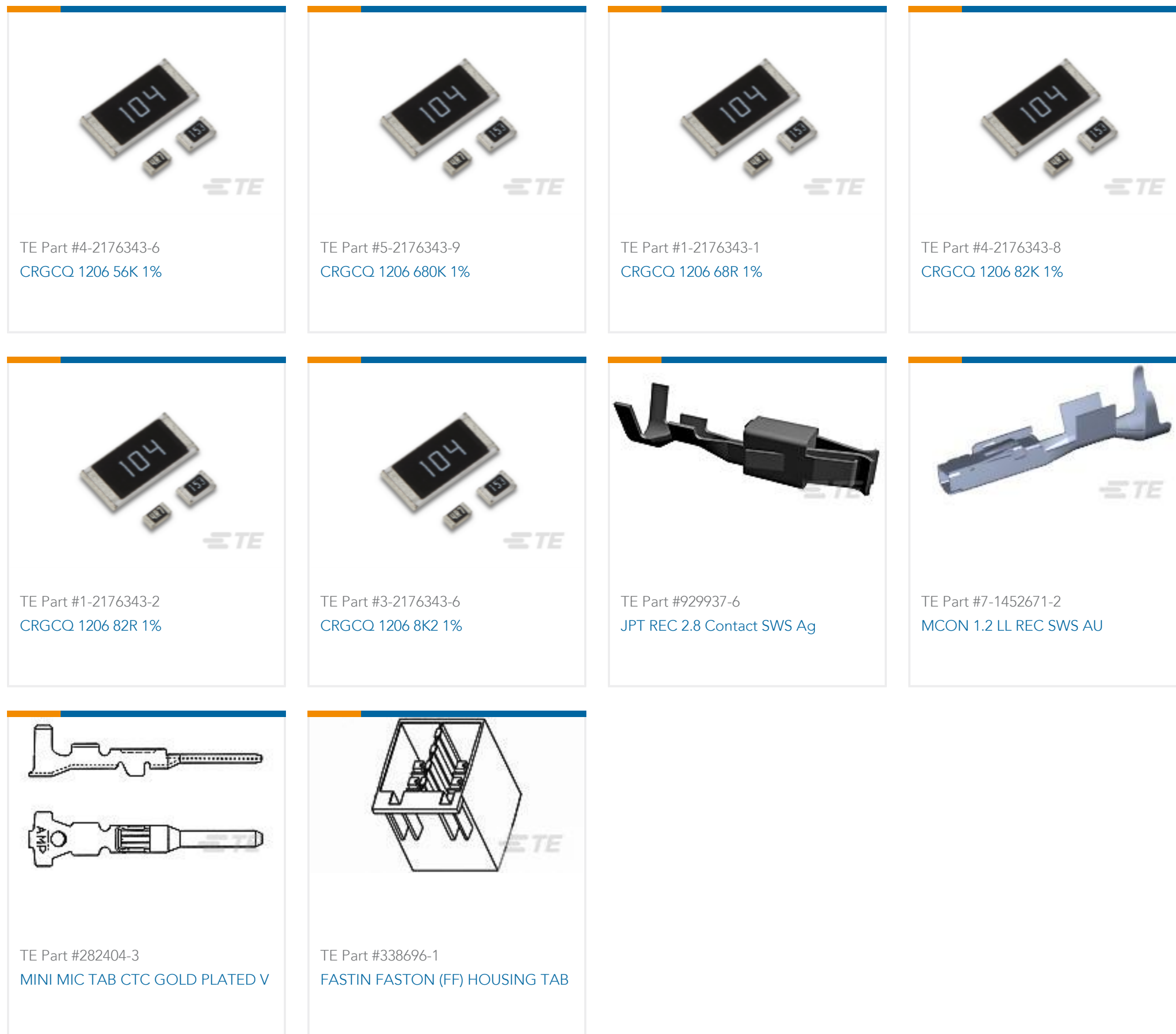
